The Affordable Apartment program offers apartment units for applicants **55 years and older**. The program has bachelor, one, two and three bedroom units. Rents are calculated at **10% below market rate** and are reviewed annually. They are as follows:

All rents include parking and utilities. Telephone charges and cable television are the responsibility of the tenant. **A security deposit equal to one month's rent is required.**

***The Pines Court apartment offers shared, coin operated laundry facilities and has adapted a smoke free policy.***

***Creekside apartment has in-suite laundry. Residents are required to provide their own washer & dryer. This building has been designated smoke free.***

Applicants, if approved, will be added to the wait list. The waiting list is based on Income Priority, serving those of the most modest incomes first, and the higher incomes following. Our waiting list is quite extensive at this time – requiring an approximate waiting period of about six months. You are welcome to contact us after that time to confirm your continuing need for housing and to check on your status.

Applicants should be aware that in order to qualify, they must be self-reliant and able to meet their own daily needs. There are no staff on site to check on residents.
